

DJ SERVICE AGREEMENT



AGREEMENT on Date of Agreement between and hereinafter referred to Sample Contact as the Purchaser, and Shawn Cheatham d.b.a. DJ Shawn.

THIS AGREEMENT IS AS FOLLOWS:

1. The Purchaser hereby engages DJ Shawn to provide music service from the package of choice selected in section 7 of this agreement. The service will be performed at the location below:

2. DJ Shawn hereby agrees to provide a music sound service for the Purchaser at the above- mentioned location and the service shall consist primarily of providing musical entertainment by means of a recorded music format.
3. Music service rendered is to be the sole control of DJ Shawn with all pre-arranged programming covered prior to the time of performance. This will insure customer satisfaction and any possible confusion.
4. Security is the responsibility of the Purchaser and must be acceptable in allowing DJ Shawn to perform in a safe environment. DJ Shawn and/or affiliate(s) are not responsible for the behavior of wanted and/or unwanted guest at this function. Any damages resulting of this nature are the sole responsibility of Host/Purchaser. This clause includes any possible damage made to DJ Shawn's equipment in such infraction/incident.

5. The type, date, and time of engagement is as follows:

There is a minimum of 3 hours required to engage business with DJ Shawn and location must be open 1-hour prior for basic set-up, 2 hours for premium set-up.

6. All fees must be paid in full prior to the event and payments made by check should be made out to Shawn Cheatham. A deposit of 25% of the fee is required immediately to secure services for the selected date and times in #5 of this Agreement. All deposits are nonrefundable unless cancellation of engagement is the fault of DJ Shawn.
7. Circle or highlight one of the following packages you desire for your function:



- A. \$500 = Sound/Music set-up for space that accommodates up to 100 people events for 4 hours of play. (NO Light Effects)
- B. \$550 = Sound/Music & Lighting Effects set-up for space that accommodates up to 100 people events for 4 hours of play.
- C. \$600 = Sound/Music set-up for space that accommodates 100 – 300 people events for 4 hours of play. (NO Light Effects)
- D. \$650 = Sound/Music & Lighting Effects set-up for space that accommodates 100 – 300 people for 4 hours of play.
- E. \$800 - \$1000 = Sound/Music set-up for space that accommodates concert setting accommodating over 300 people.
- F. Special Agreement and Arrangements = \$500 for 5 hours of sound/music for unknown amount of people in outdoors setting. Generator not necessary for power, but gazebo set-up maybe required for equipment protection.

Add \$50 for each additional hour for extended play request. These requests are very common, so if feasible, extended play can be accommodated.

Additional Terms and Conditions

The agreement of DJ Shawn to perform is subject to proven detention by accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond control. If such circumstances arise, all reasonable efforts will be made by DJ Shawn to find replacement entertainment at the agreed upon fees. Should DJ Shawn be unable to procure a replacement, Purchaser shall receive a full refund. Purchaser agrees that in all circumstances, DJ Shawn's liability shall be exclusively limited to an amount equal to the paid performance fee and shall not be liable for indirect or consequential damages arising from any breach of contract.
